# Financial Report - Discussion of Hilda's report

- A "New Pool Reserve" account has been established with donations received to date for efforts related to building a new pool at the LRD
- CD expired in September, and another CD to expire in October.
- Pool rental this year has been less this year compared to last year with 3 rentals
  - Have seen an uptick in events during open hours, with attendees paying guest fees
- Drop in swim, swim lessons, and property tax revenue account for the bulk of the budgeted revenue surplus this year
- Tracking towards a positive net cash flow for the year
- Mgmt to sync up with Chase

#### **Managers Report**

- Pool staffing lean but holding the fort!
- Facility updates
  - Tree company doing moth work
  - o PG&E cut a fair amount of overgrowth leading up the driveway and in parking lot
  - Lights on tennis courts
    - One of the ballasts shorted, causing 5 bulbs to blow out. Ballast and bulbs replaced.
    - Quick discussion does it make sense to invest in a lift?
      - Requires lift rental, licensed workers, etc general alignment to steer clear of that approach.
    - Research underway on LED replacement
- Merry Go Round replacement has been ordered; here hopefully within 2 months
- Year Round Lap Swimming Program Pilot
  - Estimate is \$40k to keep pool open during winter hours
  - As of today 18 lap swimmers have signed up expressing support and willingness

- to pay
- Current thinking is from early January through the end of April 2020.
- Next steps are to confirm lifeguard and then firming up commitments by the beginning of December.
- Going to give it a try!
