## 6 p.m. Call Meeting to Order

1. Consider bid protest; California Environmental Quality Act exemption; and award construction contract for Aquatic Facility Renovation to Tricon Construction Inc. dba Tricon Aquatics ("Tricon").

Recommended Action: (1) Find the Aquatic Facility Renovation project is exempt from the California Environmental Quality Act; (2) Determine that the bid submitted by the apparent low bidder, CWS Construction Group, Inc. ("CWS"), is nonresponsive; (3) Award the construction contract to the lowest responsive, responsible bidder, Tricon, for an amount of \$3,649,872; (4) Authorize the General Manager to execute the contract on behalf of the District, subject to approval as to form by the District Counsel.
